Requisition Order Under The Epidemic Diseases Act, 1897

In supersession of all earlier orders mentioned under (5), by virtue of power vested in me under section-2(ii) as 'Authorized Person' vide above said notification, and section I I (vii) read with section12, h hereby declare 19 Hospitals as per the Annexure- 1, as "Designated COVID-19 Hospitals" for isolation of the cases for COVID-19 for Surat Municipal Corporation. This order will be effective immediately and till further notice by undersigned.

The private hospitals designated as COVID-19 Hospitals shall provide 50% of the total numbers of Beds in such hospitals for patients to be referred by SMC and rest 50% shall be admitted and treated privately on their own. The Schedule of rates is prescribed in Annexure-2.

Further, following conditions shall apply

- (1) No Private Hospital within the SMC limit, whether designated of not as COVID-19 Hospital, is permitted to charge above the ceiling rates prescribed in the schedule at Annexure-2.
- (2) Nurses will continue to discharge their duties at the same hospital/work place as before and no change in hospital/work place is allowed without prior permission of SMC.

Deputy Municipal Commissioner (Health& Hospital), Surat will execute an agreement with the hospitals listed in Annexure-1.

The staff will be at disposal of the S.M.C. administration of the concerned area for discharging the duty of containment measures. Any person / Institution /organization found violating any provision of these regulations shall be deemed to have committed punishable offence under section 188 of Indian Penal Code (45 of 1860).
